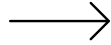

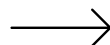
# Implementation of Localization| Process



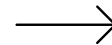
- Sign Agreement
- Decide which parts of the package that should be delivered



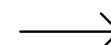
- Plan implementation
- Secure the right resources
- Kick-off



- Solution installed and configured in customer test tenant
- Solution tested by Stretch and customer
- Stretch trains max. 5 users (2-4 hours training)
- Go Live decision made jointly between Stretch and customer



- Solution deployed on decided Go Live-date.



- Support of the Localization is included in the monthly fee for the solution.
- Tickets raised in the support portal in Monday and marked as Localization

  - Access to new functionality planned in the roadmap as well as any future improvements.

**Price : 7900 SEK/month**

**Price : 750 EUR/month**

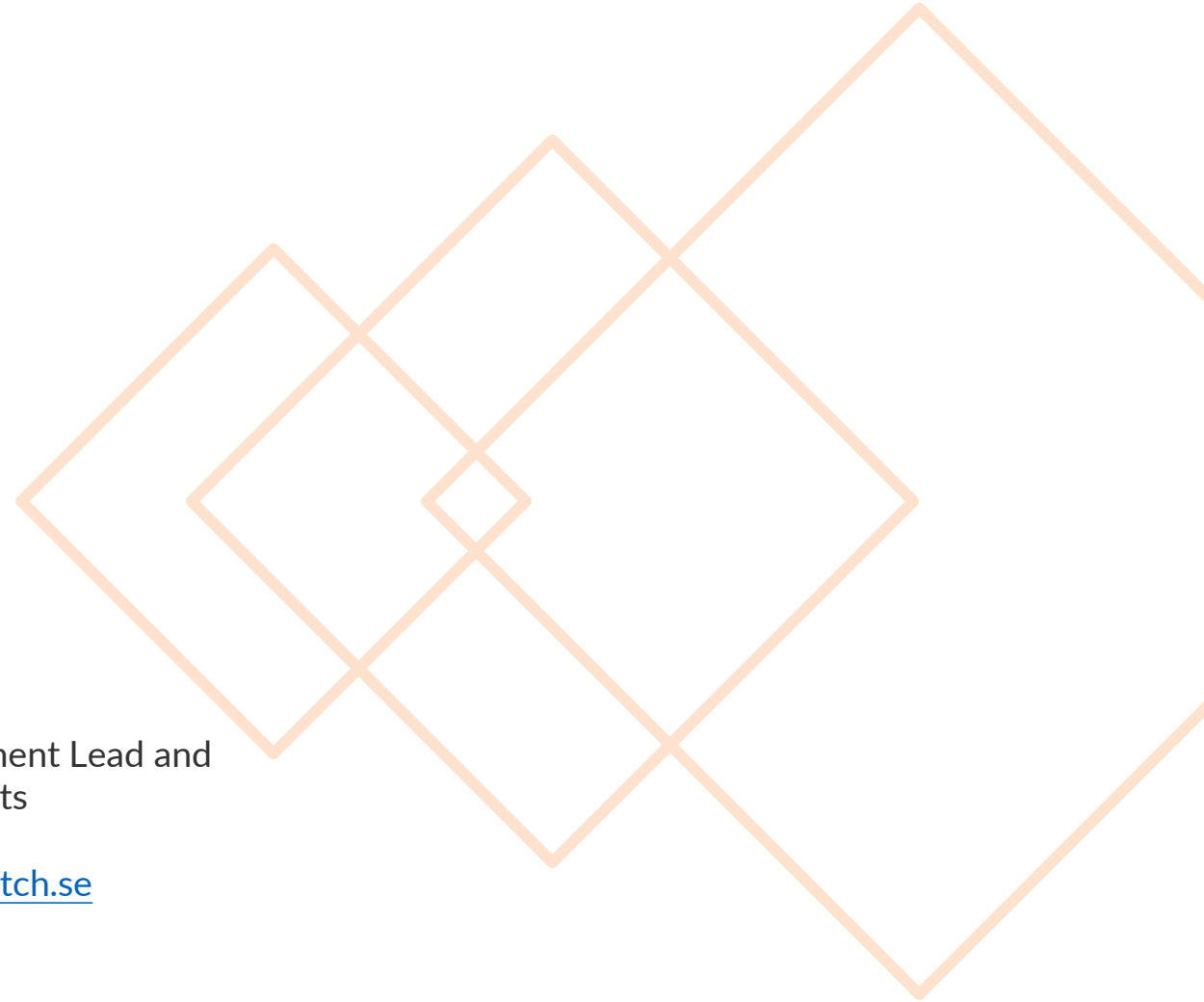
